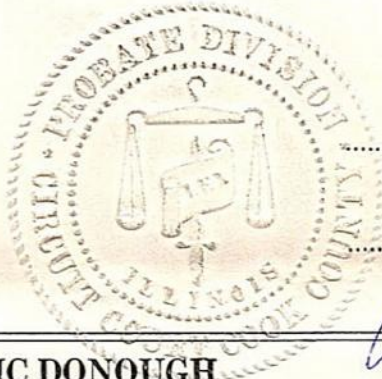

INDEMNITY AGREEMENT

WHEREAS, ADELAIDE C. SHEEHAN, who died on the 28th day of June, 1965, at the time of her death was the owner of a Savings Account #63891 at La Grange State Bank, with a balance of Five Thousand One Hundred Six and 57/100 (\$5,106.57) and a Checking Account at the LaGrange State Bank with a balance of Four Hundred Three and 51/100 (\$403.51); AND

WHEREAS, ADELAIDE C. SHEEHAN left a Will which has been filed with the Unproven Wills with the Clerk of the Circuit Court of Cook County, Illinois, Probate Division, a copy of said Will being hereto attached; AND

WHEREAS, JAMES C. SHEEHAN, NELL M. FIEG, and ALICE L. PHILLIPS are her only heirs at law and the beneficiaries named in said Will; AND

WHEREAS, the undersigned heirs at law and legatees of the said ADELAIDE C. SHEEHAN have requested the payment of said Savings Account and Checking Account to JAMES C. SHEEHAN, the Executor named in said Will, and the La Grange State Bank is willing to pay the proceeds of said two accounts to JAMES C. SHEEHAN, PROVIDED receipted bills for the following unpaid bills are presented to it, to-wit:

The undersigned, NELL M. FIEG and ALICE L. PHILLIPS, do hereby assign and transfer to

JAMES C. SHEEHAN all their interest in said two bank accounts, and the undersigned further authorize the La Grange State Bank to make payment of the above-mentioned unpaid bills if the same have not been paid and unreceipted bills exhibited therefore, and to pay the balance in its hands to JAMES C. SHEEHAN, the Executor named in said Last Will.

NOW, THEREFORE, the undersigned in consideration of the payment of the balance in said Savings Account and said Checking Account in the total sum of Five Thousand Five Hundred Ten and 08/100 (\$5,510.08) to JAMES C. SHEEHAN less payment of the debts herein before listed, AGREE to save and keep harmless the said La Grange State Bank from any and all claims that may be made against said bank because of the payment of said sums, including any expenses and attorney's fees incurred; and the undersigned jointly and severally AGREE that they will promptly repay to the La Grange State Bank, upon demand, any sums which said bank may be required to pay by way of claims, or otherwise, against or arising out of the estate of ADELAIDE C. SHEEHAN.

IT IS FURTHER AGREED that after the payment of the above mentioned claims against the estate of ADELAIDE C. SHEEHAN that the balance of said accounts will be distributed in equal shares to the three (3) children of ADELAIDE C. SHEEHAN mentioned above.
