

Teachers' Retirement System of the State of Illinois

Dear Teacher:

1. Read carefully every word on both sides of this Prior Service Certificate.

2. File this certificate for safe and convenient reference.

3. It contains your pension system number. Always refer to this number when writing to the Retirement office.

4. This Certificate shows the number of years' teaching credit you have prior to 1939, and also any contingent or out of state teaching. Current teaching, or teaching since July 1, 1939, for which you have paid is automatically credited to your account.

5. You owe the amount shown just above the dark black line and arrow.

There will be no interest charge on this amount if paid on or before July 1, 1946. If not paid on or by July 1, 1946 you are then required by law to pay interest on the amount indicated, at 4% compound interest from April 1, 1946 until paid, provided you wish credit for this teaching to count toward a pension. Be sure to make check or bank draft payable to Conrad F. Becker, State Treasurer, but mail this amount to the Retirement office.

6. The law passed in 1915 required contributions of \$5.00 per year for the first ten years, \$10.00 per year for the next five years, and \$30.00 per year for the last ten years of 25 years, producing \$400.00 for that time. In 1933 that law was amended requiring \$10.00 per year for the first ten years; \$20.00 per year for the next five years, and \$30.00 per year for the last ten years of 25 years, producing \$500.00 for that time. The law provided that if amounts so due were not paid then, interest would be charged until the amounts were paid. In other words, contributions were doubled by law in 1933 for the first fifteen years, together with interest thereon.

7. This Certificate is a report based on the sworn statements of service, submitted in your claim for teaching credit, as supported by affidavits from employing districts, and as approved by the Board in accordance with the provisions of the law.

8. These certificates are going out to thousands of teachers and in order that unnecessary correspondence may be avoided, this office will deeply appreciate each teacher reading <u>every word</u> of the Certificate and examining every explanation as to the items shown.

YEARS OF SERVICE CREDIT

Total: The figures in this certificate include all teaching service for public schools and institutions, both in and out of the system, for military service and for professional training, for which credit was claimed by the teacher and allowed by the Board. These figures include all allowable contingent service (not to exceed ten years) and may, therefore, be reduced at the time of retirement if the contingent (out of system) service then exceeds 2/5 of the total of all service both before and after July 1, 1939.

Contingent: The figures shown in these columns include credit for teaching in public schools or institutions out of the state or out of the system for which credit is limited by law to a total of 10 years and to 2/5 of the total creditable service both before and after July 1, 1939. Only so much of this service as is within these limits can be considered at retirement. Contingent service in excess of 10 years is not included as it cannot be considered in any event.

Latest Date Included: Latest Date included represents the date prior to which creditable service is included in this certificate. All Service on or after this date will be considered currently and will automatically be credited to the teacher's account.

BASIC EARNINGS AND SALARY

Actual Earnings: This figure is the total of the amounts actually received by the teacher during all allowable service periods in the base period upon which prior service credits are to be determined, namely, July 1, 1929 to June 30, 1939.

Annual Rates: This figure is the total of the amounts which would have been received by the teacher for the years during which any service credit is allowed in the base period, namely, the 10 school years from July 1, 1929 to June 30, 1939, had the teacher worked the entire year and received full salary for each year so worked.

REQUIRED PAYMENTS

Amount Paid: This figure is the total of all amounts received, both before and after July 1, 1939 (but prior to date of this certificate) applicable to service prior to July 1, 1939 only. Deductions from salary for service after July 1, 1939 was not included; they are credited directly to the account of the teacher for membership service under the new law.

Amount Due Prior Service: The figure includes the amount of back assessment and the required interest due until the date shown in the "Date Due" column and is the amount which must be paid by the teacher to obtain full credit for all service from July 1, 1939 to the date shown in the "Last Date Included" column.

Amount Due Membership Service: This figure includes the amount of back assessments and the required interest due until the date shown in the Date Due Column and is the amount which must be paid by the teacher to obtain full credit for all service from July 1, 1939 to the date shown in the "Last Year Included" column.


Total Amount Due: The figure in the "Total Amount Due" column indicates the total amount of back assessment and the required interest until the date indicated in the "Date Due" column which must be paid by the teacher to the system in order that total credit can be granted for Prior Service and Membership Service. If this amount is not paid within 90 days after such date, additional amounts representing interest at 4% compounded annually on the amount owed for Prior Service and interest at 3% compounded annually on the amount owed for Prior Service and interest at 3% compounded annually on the amount owed for Prior Service and interest at 3% compounded annually on the amount owed for Membership Service will be required.
